2. Mr.D.Ravichander, learned Special Government Pleader, accepts notice on behalf of the respondents.

3. The petitioner has filed supporting documents along with his application, dated 26.12.2024 with the respondents 3 and 4 seeking for issuance of patta for the property morefully described in the affidavit filed in support of this writ petition. Since the said application has not been considered till date, the petitioner has filed this writ petition.

4. No prejudice would be caused to the respondents, if the petitioner's application seeking for issuance of patta is considered on merits and in accordance with law, within a time frame to be fixed by this Court, after hearing the objections, if any, from the neighbouring land owners as well as any third party as they deem fit.

For the foregoing reasons, this Writ Petition is disposed of, by directing the 4th respondent to pass final orders on merits and in accordance with law, on the petitioner's application, dated 26.12.2024 seeking for issuance of patta in the name of the petitioner for the property morefully described in the affidavit filed in support of this writ petition, after giving due consideration to the supporting documents filed by the petitioner and after hearing the objections, if any, from the neighbouring land owners as well as any other third party, whom the 4th respondent deems it fit to enquire, within a period of twelve (12) weeks from the date of receipt of a copy of this order. No costs.
