Devu Bai W/o late M. Gangadhar.

ORDER : (ORAL)

Heard Ms. G.Deepthi, learned counsel for the petitioner;  
Mr. L.Ravinder, learned Assistant Government Pleader for Revenue,  
appearing for respondents No.3 and 4; and perused the material on record.

2. The petitioner claims to be the owner and possessor of the land admeasuring Acs.2-10 guntas in Survey No.9/63/1, situated at Beltaroda Village, Tanoor Mandal, Nirmal District, having inherited the same from her husband by name Mr. M.Gangadhar, who in turn inherited the same from his father by name Mr. Edvanna. The name of the petitioner was mutated in the revenue records and she was also issued e-pattadar pass book No.T14190040447 with Khata No.60006 in respect of the subject land. However, in the month of July 2024, the petitioner came to know that the revenue authorities blocked her land with an endorsement 'Court Case CBI

Case No.RC/BD1/2014/E/2024'. According to learned counsel for the petitioner, the land of the petitioner was wrongly included in the prohibitory list maintained under Section 22-A of the Registration Act 1908. The petitioner has verified the online registration portal and the same does not contain Survey No.9/63/1. Aggrieved thereby, the petitioner submitted online application through Prajavani vide registration No.TAHTN/E/2024/00023 dated 15.07.2024 to respondent No.4 for unblocking her land admeasuring Acs.2-10 guntas in Survey No.9/63/1, situated at Beltaroda Village, Tanoor Mandal, Nirmal District, however the same has not been considered. As there is inordinate delay on the part of the respondent authorities in considering the application of the petitioner, she is constrained to approach this Court.

3. Learned Assistant Government Pleader for Revenue submitted that in response to the Prajavani application dated 15.07.2024 submitted by the petitioner, respondent No.4 submitted report vide proceedings No.B/520/2024 dated 23.07.2024 (Ex.P-4) to respondent No.3 recommending unblocking/removal of the land of the petitioner from the prohibitory list.

4. In the circumstances, this writ petition is disposed of directing respondents No.3 and 4 to consider the online application of the petitioner online application through Prajavani vide registration No.TAHTN/E/

2024/00023 dated 15.07.2024 for unblocking her land admeasuring Acs.2-10 guntas in Survey No.9/1, situated at Beltaroda Village, Tanoor Mandal, Nirmal District, by duly taking into account the report of respondent No.4 dated 23.07.2024, and by giving opportunity of hearing to the petitioner and to all other concerned/interested persons, and pass appropriate orders in accordance with law, within a period of four (4) weeks from the date of receipt of a copy of this order. There shall be no order as to costs.

As a sequel thereto, miscellaneous applications, if any, pending in this writ petition, stand closed.

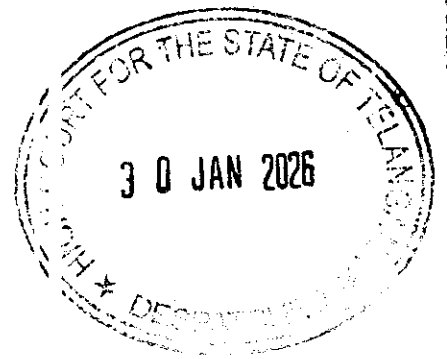
