**ORDER**

(Order of the Court was made by **P.VELMURUGAN, J.**)

The father has filed this Habeas Corpus Petition seeking a direction to the respondents/police to produce her daughter/detenué namely, Kayalvizhi, aged about 17 years before this Court.

2. The detenué while studying 1<sup>st</sup> year B.Tech at M.A.M College, Tiruchirappalli, went missing. The respondents/police have now produced the detenué before this Court. The parents of the detenué are also present. We enquired the detenué. She expressed her willingness to go along with her parents and also to pursue her studies.

3. Recording the statement of the detenué, this Habeas Corpus Petition is closed. The 2<sup>nd</sup> respondent/police is directed to inform the college management of M.A.M College, Tiruchirappalli, where the detenué is studying, not to permit any one to contact the detenué except her parents.
