Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate writ, order or direction, declaring the action of the respondents in not increasing the wards reserved for Scheduled Tribe (ST) category in Mahabubnagar Municipal Corporation, as notified in GOVERNMENT OF TELANGANA, MAHABUBNAGAR DISTRICT GAZETTE, Gazette No. 01/2026 dated 17.01.2026, as illegal, arbitrary and violative of Articles 243-P(g) and 243-T of the Constitution of India, Consequently set aside the said notification insofar as it relates to reservation of ST wards and direct the respondents to increase the number of wards reserved for ST category in Mahabubnagar Municipal Corporation in accordance with constitutional mandate.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to stay the operation and implementation of the notification issued in GOVERNMENT OF

TELANGANA, MAHABUBNAGAR DISTRICT GAZETTE, Gazette No. 01/2026 dated 17.01.2026, insofar as it relates to reservation of wards for the Scheduled Tribe (ST) category in Mahabubnagar Municipal Corporation, in the interest of justice and equity., pending disposal of WP No. 1880 of 2026, on the file of the High Court.

ORDER

There shall be interim direction to respondent Nos.2 and 4 to consider the representation of the petitioner dated 20.01.2026 for increasing the wards reserved under ST category in Mahabubnagar Municipal Corporation in proportion to the increase in ST population, and pass orders, in accordance with law, by affording opportunity of hearing to the petitioner, within a period of ten (10) days from the date of receipt of a copy of this order.
