Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of Writ of Mandamus challenging the action of the respondents more particularly respondent Nos.2 to 5 herein in trying to interfere, dispossess the petitioner from his agricultural land admeasuring Ac.00-0750 Guntas in Sy.No.83LU3/2/1 and land admeasuring Ac.00-1150 Guntas in Sy.No.83LU3/1/1, total admeasuring Ac.00-19 Guntas situated at Reddipalle Village, Moinabad Mandal, Rangareddy District having TD-cum-Pass Book bearing No.T05180040710, that too without following due procedure of law as illegal, arbitrary, in violation of principles of natural justice and to consequently direct the respondents herein not to interfere, dispossess the petitioner from his agricultural land admeasuring Ac.00-0750 Guntas in Sy.No.83LU3/2/1 and land admeasuring Ac.00-1150 Guntas in Sy.No.83LU3/1/1, total admeasuring Ac.00-19 Guntas situated at Reddipalle Village, Moinabad Mandal, Rangareddy District.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents herein not to interfere, dispossess the petitioner from his agricultural land admeasuring Ac.00-0750 Guntas in Sy.No.83LU3/2/1 and land admeasuring Ac.00-1150 Guntas in Sy.No.83LU3/1/1, total admeasuring Ac.00-19 Guntas situated at Reddipalle Village, Moinabad Mandal, Rangareddy District, pending disposal of WP 5757 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of M/s. KATIKA RAVINDER REDDY, Advocate for the Petitioner, GP FOR REVENUE for the Respondent Nos.1 to 4 and Sri K. Pradeep Reddy, Standing Counsel for the Respondent No.5, the Court made the following.

ORDER:

The petitioner claims to be the owner and possessor of the land admeasuring Ac.0-0750 guntas in Survey No.8303/2/1 and Ac.0-1150 guntas in Survey No.8303/1/1, total admeasuring Ac.0-19 guntas, situated at Reddipalle Village, Moinabad Mandal, Ranga Reddy District on the strength of e-pattadar pass book bearing No.T05180040710 with Khata No.60665.

Hence, there shall be interim direction to respondents No.3 to 5 not interfere with the possession of the petitioner in respect of the subject land without following due process of law.
