Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an Order or Direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the respondents 2 to 4 in issuance of show cause notice No. 48/UC/CIR-15/TPS/GHMC/2025 dated 23-12-2025 after receiving the explanation to the show cause notice on 19-1-2026 without passing the order initiated the action against the petitioner premises Bearing No. 1-8-1/B8/F4 with plinth area 700.00 S.FT. Property bearing No. MIG-II, Phase. I, Block No. 8, Flat No. 4, Ground Floor , Baghlingampally, Hyderabad even after

receipt of the commercial taxes since 15 years by the respondents is illegal, arbitrary, contrary to law and violation of GHMC Act and Rules made there under and also violation of Article 300A of the Constitution of India and set aside the same.

ORDER : (ORAL)

Heard Mr. Mohd. Ghulam Rasool, learned counsel for the petitioner; and Mr. G. Madhusudhan Reddy, learned Standing Counsel for GHMC - respondent Nos.2 to 4; and perused the material on record.

2. Show cause notice dated 23.12.2025 was issued to the petitioner by respondent No.3 - the Deputy Commissioner, Circle - 41, GHMC, Abids, Hyderabad, on the complaint lodged by

respondent No.5 alleging illegal construction of shops by occupying common area and footpath of premises at Pr.No.Flat No.4, Block No.8, MIG-2, Bachlingampally, Hyderabad, directing him to submit explanation to the show cause notice within fifteen (15) days.

3. The learned counsel for the petitioner submitted that explanation was submitted to the show cause notice on 19.01.2026. However, without considering the explanation of the petitioner, the municipal authorities are threatening her to vacate the subject property stating that they would demolish the same.

4. The learned Standing Counsel for GHMC submitted that the petitioner did not appear before the authorities on 19.01.2026 and instead of submitting explanation to the show cause notice, she has rushed to this Court. However, the learned counsel for the petitioner submitted that explanation dated 19.01.2026, which is filed herewith as Ex.P-2, was submitted in the Inward Section of the GHMC.

5. In the circumstances, without entering into merits of the case, the writ petition is disposed of, at the admission stage itself, directing respondent No.3 - the Deputy Commissioner, Circle - 41, GHMC, Abids, to consider the explanation dated 19.01.2026 submitted by the petitioner to the impugned show cause notice and pass orders in accordance with law by affording opportunity of hearing to the petitioner and respondent No.5. Further, pending enquiry pursuant to the show cause notice dated 23.12.2025, respondent No.3 is directed not to interfere with the possession of the petitioner in respect of the subject property i.e., premises at Pr.No.Flat No.4, Block No.8, MIG-2, Baghlingampally, Hyderabad. As this order is passed without entering upon merits, notice to respondent No.5 is dispensed with. However, if respondent No.5 is in any manner aggrieved by this order, he is at liberty to seek modification of this order. No order as to costs.

As a sequel thereto, miscellaneous applications, if any, pending in the writ petition stand closed.
