Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents more particularly the Respondent No.4, in issuing the impugned notice dt- 05.01.2026, for conducting of Survey to mark the footway (Nakshabatta), in the agriculture lands of the Petitioners in Sy Nos. 408, 225, 223, 230, 231, 214, 235, 243, 244, 245, 246, 397, 394, 396, 392 & 393 situated in Mucharla Village, Kandukur Mandal, Rangareddy District as illegal, arbitrary, unreasonable, violation of the provisions of Telangana Survey and Boundaries Act, 1923 besides violation of the Articles 14 and 300-A of the Constitution of India and consequently set aside the impugned Survey Notice dt- 05.01.2026 issued by the Respondent No.4.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to stay the impugned notice dt- 05.01.2026, issued by the Respondent No.4, for conducting of Survey to mark the footway (Nakshabatta), in the agriculture lands of the Petitioners

in Sy Nos. 408, 225, 223, 230, 231, 214, 235, 243, 244, 245, 246, 397, 394, 396, 392 & 393 situated in Mucharla Village, Kandukur Mandal, Rangareddy District, pending disposal of WP 2244 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Writ Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Veera Savan Chakravarthy Dara Advocate for the Petitioners, GP FOR REVENUE for the Respondents and the Court made the following.

ORDER:

Learned Senior Counsel, Mr. A. Ravinder Reddy, submitted that survey is sought to be conducted pursuant to the impugned notice dated 05.01.2026 without any prior notice to the petitioners and in violation of principles of natural justice. However, survey was not conducted on 09.01.2026 as per the notice dated 05.01.2026. Another notice dated 23.01.2026 was issued proposing to conduct survey on 29.01.2026.

As it is stated that the petitioners are pattadars of adjoining lands i.e., Survey Nos. 235/a/1, 243, 244, 393/1/a, 392/aa/2, 397, 394/a, 394/1/1/1, 394/a/2, 394/a/3 and 392/a/1 and they were not issued notice for proposed survey to be conducted on 29.01.2026, there shall be interim suspension of all further proceedings in File No.F/B/81/2024 including notice dated 23.01.2026, till the next date of hearing.

Learned Assistant Government Pleader for Revenue shall get instructions.
