ORDER:

Hence, there shall be interim direction to respondent Nos.2 to 6 not to interfere with the possession of the petitioners over the subject property i.e., agricultural land admeasuring Ac.5-21 ¼ guntas in Survey No.1469/1, Acs.5-21 ¼ guntas in Survey No.1469/2, Ac.0-14 guntas in Survey No.1479/1, Ac.0-31 guntas in Survey No.1480/1, Ac.0-38 guntas in Survey No.1481/1, Ac.0-31 guntas in Survey No.1482/1, Ac.0-14 guntas in Survey No.1479/2, Ac.0-32 guntas in Survey No.1480/2, Ac.0-38 guntas in Survey No.1481/2 and Ac.0-32 guntas in Survey No.1482/2, total land admeasuring Acs.16-32 guntas, situated

at Goparpalli Village, Odela Mandal, Peddapalli District, without following due process of law.
