COMMON ORDER :

These Writ Petitions are filed aggrieved by the inaction of the respondents in releasing retiral benefits to the petitioners.

2. Heard Sri M.Sathivik Reddy, learned counsel for the petitioners and learned Government Pleader for Services-I and III appearing for the respective respondents. With their consent, all the Writ Petitions are taken up for disposal at the admission stage itself.

3. When the matters are taken up for hearing, learned counsel for the petitioners submit that the *iss* raised in the present Writ Petitions has already been adjudicated by the Division Bench of this Court in W.P. No.23138 of 2025, which was disposed of *vide* order dated 03.09.2025, and thus prayed to pass similar order in the present Writ Petitions also.

4. The above made submission is not seriously disputed by the other side.

5. Having regard to the above made submissions and for the reasons alike in the order dated 03.09.2025 passed by the Division Bench in W.P.No.23138 of 2025, all the Writ Petitions are disposed of directing the respondents to ensure that the entire amount payable to the petitioners be released forthwith within a period of six (6) weeks from today, failing which, the entire amount with regard to retiral benefits shall carry interest at the rate of 10% per annum from the date the amount fell due till it is actually paid.

Miscellaneous petitions, if any, pending in these Writ
Petitions shall stand closed. There shall be no order as to costs.
