Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of Writ of MANDAMUS declaring the action of the respondents in constructing the compound wall and blocking the existing access way to the petitioners colony i.e., NTR Colony, is illegal, arbitrary and unconstitutional with a consequential direction to restore and

maintain the existing access way or provide alternative access road to the petitioners colony i.e., NTR Colony before constructing compound wall;

**IA NO: 1 OF 2026**

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant interim stay of construction of the compound wall which is blocking the existing access way to NTR Colony, pending disposal of WP 3473 of 2026, on the file of the High Court.

The Petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Nayakawadi Ramesh, Advocate for the Petitioners, GP For Revenue, for the Respondent Nos.1 & 2 and of Sri U. Santhi Bhushan, Standing Counsel for the Respondent Nos.4 to 10, the Court made the following.

**ORDER**

**Heard learned counsel for the petitioners, Mr. U. Shanthi Bhushan, learned standing counsel for TGSRTC and learned Assistant Government Pleader for Revenue.**

**There shall be interim direction to the respondent No.2 to consider the representation of the petitioners dated 22.12.2025 for providing road access from Armoor RTC Depot land to the colony of the petitioners by name NTR Colony, Armoor Municipality, Nizamabad, by affording opportunity of hearing to the petitioners and the respondents No.3 and 10, within a period of three (3) weeks from the date of receipt of a copy of this order.**

**Till then, status quo, obtaining as on today, shall be maintained.**
