The Petitioner had participated in the counselling process and students were admitted into college and the list of admitted students was sent to Respondent No.2-APSCHE for ratification. In the ratification process, APSCHE had rejected the certificates of the three students on the ground that their EWS certificates were not valid.</p> <p>In the interregnum, three students who joined the Petitioner-College through counselling process had opted out of B.Ed course and thereafter the Petitioner-College admitted three students in the Management</p> |             |
