**ORAL ORDER**

Heard learned counsel for the petitioner and learned AGA for the respondents and perused the material on record.

2. Learned AGA on instructions submits that there are no criminal cases pending as against the petitioner as on today. It is also submitted by learned AGA only that CC.Nos.499/2018 and 357/2019 arising out of Crime Nos.44/2017 and 27/2019 against the petitioner, which is referred to in the impugned Endorsement at Annexures-D



and E dated 24.12.2021 and 20.12.2023 have ended in an acquittal.

3. The aforesaid facts and circumstances clearly establish that in the light of the judgment referred to in the aforesaid interim order passed by this Court and the undisputed fact that the petitioner has been acquitted in CC.Nos.499/2018 and 357/2019 vide orders dated 24.12.2021 and 20.12.2023, the only reason assigned by the respondents for issuing the impugned order at Annexure-B dated 15.07.2022, is clearly erroneous and the same deserves to be quashed.

4. In the result, I pass the following:

**ORDER**

- i) The petition is hereby ***allowed***.
- ii) The impugned order at Annexure-B, dated 15.07.2022 is hereby set aside.



iii) Name of the petitioner is directed to be deleted from the rowdy sheeter list/rowdy register within a period of three weeks from the date of the receipt of a copy of this order.
