3. Heard the learned Additional Public Prosecutor for respondents 1 and 2 and perused the materials on record.

4. Considering the submission made and on perusal of the materials, it is seen that the petitioners are from one family. The petitioners 1 and 2 are the parents of Ajithkumar who had married the defacto complainant. It was an intercaste marriage. There was a matrimonial discord between the said Ajithkumar and the defacto complainant and now it has been projected since the defacto complainant belongs to SC community. The petitioners have caused harassment and humiliation and now Ajithkumar has arrested in this case. It is a matrimonial discord and the preliminary allegations against the petitioners stems out of a matrimonial discord.

5. In view of the above factual position, there shall be a direction to the learned District Sessions and Special Judge for exclusive Trial of SC/ST Cases, Kallakurichi, to consider the petitioners' bail application,

preferably on the same day of their surrender, in connection with Crime
