Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondent No. 4 and 5 to de-freeze the Petitioners Savings Bank Account bearing No. 32437548715 maintained with State Bank of India, Telhara Branch and Savings Bank Account bearing No. 501007724027075 maintained with HDFC Bank, Telhara Branch respectively and permit the Petitioner to operate the same without any restrictions, pending disposal of WP No.13820 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Rupesh Mittal, Advocate for the

ORDER:

This petition is filed seeking a direction to respondent Nos.4 and 5 to defreeze the petitioner's savings bank Account bearing No.32437548715, maintained at State Bank of India, Telhara Branch and the Savings Bank Account bearing No.501007724027075, maintained at HDFC Bank, Telhara Branch, respectively, and to release all funds except the disputed amounts of Rs.4,000/- and Rs.1,436/- respectively.

Heard learned counsel for the petitioner.

As per the petition, the petitioner is holding an account with respondent Nos.4 and 5. On 30.12.2025, a sum of Rs.4000/- was credited to the Petitioner's HDFC Bank Account as a reward for participating in an online game and the petitioner thereafter transferred an amount of Rs.1,436/- to the SBI Bank Account. Subsequent to the said transactions, respondent Nos.4 and 5 have freezed the petitioner's bank accounts. The petitioner submits that barring the disputed transactions involving Rs.4,000/- and Rs.1436/-, the petitioner may be permitted to operate the accounts.

In view of the facts and circumstances, respondent Nos.4 and 5 are directed to unfreeze the petitioner's account, barring the amount involved in unauthorized transactions i.e., Rs.4,000/- and Rs.1436/-.
