**ORDER:**

Heard learned counsel for the petitioner.

2. Aggrieved by the impugned order dated 20.11.2025 passed in I.A.No.941 of 2025 in A.S.No.157 of 2025 granting stay of execution of the decree passed in O.S.No.1668 of 2021 on the file of learned V Additional Civil Judge (Junior Division), Vijayawada on condition of depositing of 50% of the decadal amount within two months and in default, that the petition shall stand dismissed, the present revision petition has been filed by the petitioner.

3. The only grievance of the revision petitioner is relating to deposit of 50% of the decadal amount while granting stay of execution of the decree. Learned counsel for the petitioner submits that the 50% of the decadal amount comes to Rs.3,14,217/- along with interest and the petitioner is not in a position to deposit the same as he is only an employee in a Thermal Power Station. Therefore, he only prays to modify the said order by reducing the amount to be deposited.

4. Therefore, considering the said request, the Civil Revision Petition is disposed of modifying the impugned order of granting stay of execution of the decree on deposit of a sum of Rs.2,00,000/- in total within one month from the date of this order before the first appellate Court, failing which, the order of stay stands vacated without any further reference to this Court. There shall be no order as to costs.

Pending applications, if any, shall stand closed.
