Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly a Writ of Mandamus, declaring the action of the Respondent No.2 authorities in taking up revision proceedings under the Telangana Assigned Lands (Prohibition of Transfers) Act, 1977 pursuant to Notice No. E2/2081/2025, dated 20-01-2026, in respect of land in Sy.No. 753 and lands in Sy.Nos. 867, 870, 871, 872, 873, 875 and 853 situated at Korremula Village, Ghatkesar Mandal, Medchal-Malkajgiri District, as illegal, arbitrary and violative of principles of natural justice, and consequently direct the respondent No.2 not to take any coercive steps against the petitioner's possession and enjoyment of the subject land until disposal of the revision proceedings by the Additional Collector.

IA NO: 1 OF 2026

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased To direct the Respondent No.2 and their sub-ordinates not to take any coercive steps against the petitioner in pursuance of the notice vide E2/2081/2025, dated 20.01.2026 in respect of land in Sy.No. 753 and lands in Sy.Nos. 867, 870, 871, 872, 873, 875 and 853 situated at Korremula Village, Ghatkesar Mandal, Medchal-Malkajgiri District of the pending disposal of WP 4927 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the Writ Petition and the affidavit filed in support thereof and upon hearing the arguments of M/s. Abk Siva Kasulu Advocate for the Petitioner, GP FOR REVENUE for the Respondent Nos.1 to 4, the Court made the following.

ORDER:

Learned counsel for the petitioner submitted that suo moto revision has been taken up by respondent No.2 under Section 4B of the Telangana Assigned Lands (Prohibition of Transfers) Act, 1977 against the order dated 10.03.2006 passed by respondent No.3 bearing No.B/2051/2004 after a period of twenty (20) years and there is unreasonable and unexplainable delay.

The matter requires consideration.

As there is delay of 20 years in taking up the suo moto revision, there shall be interim suspension of the notice dated 10.03.2006 until further orders.
