**: ORDER :**

This Writ Petition is filed seeking the following relief:

*"to issue an appropriate Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondent No.5 in withholding the Petitioners original Certificates as illegal, unjust and violation of principles of natural justice and restrain the institution/ Colleges from withholding original certificate due to outstanding amounts for the Government or any including unpaid fees and regulations mentioned under Rule 2(F)(6) and Rule 4(c) issued by UGC notification vide file No.14-4/2012(CPP-1) in October 2018 and Cir.No.JNTUH/DAAA/Students/Fee Reimbursement/2024, Dated 07.03.2024 an violations issued by Respondent No.4 and AITCE Circular F.No.1-101/DPG/AITCE/Regulations/2019 dated 29/03/2019 vide letter dated 05.08.2024 and violation of Article 14, 19 and 21 of Constitution of India. Consequently, direct the Respondents to issue all the Original Certificates including Long Memo, Study and Conduct Transfer Certificate of SSC, Intermediate, All Semesters Memo and Bonafide Certificates along with Provisional and Consolidated Marks Memos of Engineering holding with Respondent No.5 and pass..."*

2. Heard Mr. Y.V.S.S.Siva Sarma, learned counsel for the petitioners, Mr. K.Sharath, learned Assistant Government Pleader for Higher Education appearing for respondent Nos.2 and 3 and Mr. Prabhakar Peri, learned Standing Counsel for JNTU appearing for respondent No.4. There is no representation for respondent No.6.

3. Case of the petitioners is that they have pursued their Engineering course in respondent No.6 college and upon completion of their studies, they have approached the management for return of their original certificates by making several representations. However, respondent No.6 refused to return their original certificates and insisted them to pay the entire fee for the full four year course, relying upon the guidelines issued by the Finance (SCSDF & STSDF) Department *vide* U.O.No.27000860/A/97/SCSDF/202, dated 06.09.2024. Hence, the present writ petition.

4. Learned counsel for the petitioners submits that the AICTE, *vide* Lr.No.1-101/PG/AICTE/Regulation/2019, dated 29.03.2019 and the Telangana State Council of Higher Education by Lr.No.TSCHE/Fee Reimbursement/2024, dated 23.02.2024, have directed the Directors/Principals and Registrars of all the universities

not to withhold or retain the original certificates of students and not to insist upon payment of fees from students who are eligible for fee reimbursement.

5. Learned counsel for the petitioners submits that as a result of the action of respondent No.6 college in withholding the original certificates, the petitioners were irretrievably deprived of the opportunity to submit applications for further studies at their institution of choice for TS/TG PGSET 2026 to 2028 Phase-II. The petitioners are not in a financial position to pay the amount demanded by respondent No.6. He further submits that the action of respondent No.6 in withholding the original certificates of the petitioners is illegal and arbitrary. Therefore, he seeks a direction to respondent No.6 to forthwith return the petitioner's original certificates.

6. Perused the record.

7. It is not in dispute that the petitioners have completed their studies in respondent No.6 college and their original certificates are in the custody of the said college. A bare perusal of the Lr.No.TSCHE/Fee Reimbursement/2024, dated 23.02.2024 issued by the Secretary, Telangana State Council of Higher Education,

reveals that specific instructions were issued directing all affiliated Private Colleges not to insist upon payment of tuition fees from students who are eligible for the fee reimbursement from the State Government. Further, as per the guidelines of UGC, no college is entitled to withhold or refuse to return any documents, including degree or diploma certificates or any other awards deposited with it by students for the purpose of seeking admission.

8. The certificates, being personal and academic credentials, are undoubtedly the property of the petitioners. In such circumstances, respondent No.6-college has no authority whatsoever to retain the said certificates and the retention of the petitioner's original certificates by respondent No.6 is wholly unjustified and cannot be sustained. Even assuming that the college has any monetary claim against the petitioners, withholding their original certificates cannot be adopted as a mode of enforcing such claim. The proper remedy, if any available to the college is to proceed in accordance with law for recovery of its dues and not by depriving the petitioners of their rightful original certificates.

9. For the foregoing discussion, this Writ Petition is allowed, directing respondent No.6 to forthwith return the original certificates of the petitioners to them, within a period of one (1) week, from the date of receipt of a copy of this order. No costs.

Pending miscellaneous applications, if any, shall stand closed.
